## Responsibilities include:

- Attending all shows for the run the production
- Supervising front of house staff, including but not limited to the Box Office Manager, the Bar Manager, and occasional additional ushers or volunteers.
- Managing the movement and the seating of the audience. The location may be unconventional two out of our three shows this season are in site specific locations.
- Keeping track of programs, concessions, and supplies and supervising their distribution.
- Coordinating the with the bar manager
- Working closely with the box office manager and the stage manager to develop a run of show plan and a late seating plan.
- Helping to develop and implement a safety plan for the audience, in case of an emergency.
- Light Housekeeping taking out trash, replacing toilet paper, etc
- Completing a nightly House Report with information from Box Office Manager and Bar Manager included
- Other duties as required to facilitate the smooth running of the audience experience.
